14. Add-on-Course in Guidance and Counselling

The organizations of today are witnessing and practicing a shift from generalized knowledge-base to expertise and skillfulness in their work atmosphere. Consequently, the manpower needed has to be capable and talented as per the requirements and expectations of the job-market, both in public sector as well as private sector. Our college recognizes this necessity that general education needs to be supplemented with courses which are specialized, skill-based and career-oriented. Keeping in tune with the changing times, we have been introducing such courses in the wider benefit of the students. These courses can be offered along with graduation and the students are awarded Certificate, Diploma and Advance diploma in the vocation of their choice after completion of the add-on course. The courses shape them as suitably equipped performers who can make use of the skills dexterously.

The Department of Psychology, P.G. Govt. College for Girls, Sector-11 offers Add-on Course in Guidance and Counselling for the students. This is a three-year course comprising of Certificate Course (1stYear), Diploma Course (2nd year) and Advance Diploma Course (3rd year). Project work regarding various personal problems, social problems, e.g. substance abuse, drug abuse, cyber-crime, HIV/AIDS, academic problem, e.g. learning difficulties etc. is undertaken by the students under the guidance of our faculty. Students of Guidance and Counseling also carry out online projects concerning career counseling. Apart from the above-mentioned projects, various kinds of workshops and seminars are specially organized for the students of Add-on Course. Internship programmes are arranged for the advance diploma students in the area of career, emotional and educational counseling. Students of Add on course have consistent shown good academic performance. Pursuance of add-on course in Guidance and Counselling is beneficial for the students. It helps them to explore the real-life challenges faced by the individuals. Thus, they get sensitized to different

social and emotional problems of the individuals and also get an exposure to different fields of counselling.

Vision and Goals

- Making understand basic principles of individual differences in behaviour.
- Training students in applied aspects of psychology-Clinical, Counselling, Community Mental Health, Organizational and Social issues.
- Providing platform for scientific growth.
- It helps the students in making the best possible adjustment to the situation in the educational institution and in the home.

15. Departmental Activities

The departmental activities are held under the aegis of college IQAC by its society, namely *Manorang*. The society is formulated through the participation of the students via healthy practice of election. Functioning of the society enables the students to connect and bond with fellow students and faculty members of the department and thus develop a sense of belongingness with the department and college.

MANORANG – The Psychology Society

Objectives:

1. To provide a substantial platform for the students to communicate and connect with others, and thus be aware of their strengths.
2. To provide extrinsic motivation to the students for their performance in academic and co-curricular activities.
3. To provide opportunities for the students to explore their hidden talents and desires, act out these and thus work towards their growth and holistic development.
4. To provide opportunities for the students for team work and organizational skills.
5. To prepare a strong base in the discipline, paving the path to excel and become distinguished psychologists.
6. Training students in applying life skills in practical life situations.

MEHFOOZ - Drug De – Addiction Society

The primary objective of an educational institution is to provide a wholesome education that empowers the youth with knowledge, sensitizes them to the various social issues, and prepares them to become responsible citizens of the nation. Thus it becomes imperative that the institutions create a platform for the students that can generate awareness amongst them regarding key issues. One such important issue that is affecting the physical and mental health of youth is drug abuse. The educationists focus on the overall growth and development of the students. This can happen if the students are able to realize their potential, be guided and counselled for making good choices in life.

VADA (Victory Against Drug Abuse) CLUB

Inspired by the *Nasha Mukh Bharat Abhiyan*, launched by the Govt. of India, and “Nashe se Azadi: National Youth and Student Interaction Program” initiated by Hon’ble Minister Dr. Virender Kumar, Ministry of Social Justice and Empowerment, on the occasion of International Day of Drug Abuse, Principal Prof (Dr.) Anita Kaushal, launched the **VADA Club** (Victory Against Drug Abuse) in the college as per Govt of India directive. The club is associated with the Mehfooz society, and is convened by Dept. of Psychology. The student members of the VADA club work in unison with Mehfooz Society to spread awareness about drug abuse and marching towards making Chandigarh and India Drug Free.

Objectives:

1. To make the students aware about the ill effects of drug abuse on physical and mental health.
2. To generate awareness amongst the students about the importance of self-discipline and productive usage of time.
3. To emphasize various preventive steps to stay away from this menace.
4. To prepare the students to be assertive and not to be lured into the trap of drugs.

5. To prepare the students to further spread in the society the awareness regarding the causes, consequences, treatment options and preventive steps of drug abuse.
6. To educate the students about the healthy and creative pursuits they could follow and thus adopt a healthy lifestyle.
7. To guide the students to develop resilience by overcoming difficult times by exploring their latent strengths and not fall prey to substance abuse.

16. SAARTHI – The Counselling Cell

COVID-19 has disrupted personal and professional lives of every individual and the outbreak of this pandemic since almost one and a half year has caused huge emotional and psychological distress amongst each one of us. Counseling allows students to express and give voice to their concerns and worries, create awareness on anxiety issues, normalize conversations on mental health and build resilience.

The faculty of department of Psychology has been engaged in providing Guidance and Counseling to the college students since many years, but now keeping in mind the current scenario, we have decided to reinforce the ongoing efforts. And so, we formally launch “SAARTHI” – a Mental Health Support Group which stands for “Supportive and Affable Ride Towards Hope & Inner-peace”

The word Saarthi means ‘one with a chariot or charioteer’ is an epithet of Lord Krishna in the Mahabharata, the Hindu epic. Just like a charioteer who drives his horses onwards, this initiative Saarthi as a counseling cell of PGGCG-11 will ensure to help students to get rid of feelings of distress, isolation and helplessness during these harsh times and assist them by providing emotional and mental support in the form of productive counseling sessions.



17. Educational Trips

- Educational Trip – Jaipur

Psychology Department of PGGCG-11, organized an educational tour to Jaipur –the pink city, for a visit to Psychiatric Centre, Jaipur for three days and two nights from 10th March 2018 to 14th March 2018, for Psychology students of B.A. 2nd and B.A. 3rd year to give them a closer picture of the field of Clinical Psychology.

- Field visit to GRID

Fifteen students of Advanced Diploma, Guidance and Counselling of PGGCG, Sector 11 were given the opportunity to visit the Govt. Rehabilitation Institute for Intellectual Disabilities, Sector- 31 organized on **6th November, 2019**. Dr. Vijay Kumar accompanied the students for the visit. After a small introduction about the institute with Mr. Yashwinder, students gathered in the seminar hall where they were informed about how the institution began with just a handful mentally challenged students in 1964, which gradually grew with passing time and continuous awareness.

18. Internship Programmes

- Internship at DRDO

Students of first batch of M.A. Psychology (2018-2021) attended an internship programme of one month at Defence Institute of Psychological Research, Defence Research Development Organization (DRDO), Ministry of Defence, Delhi from **1st to 30th June 2019**. The DIPR organization allowed only 11 students for the Internship programme. Being the first batch of M.A Psychology of PGGCG-11, the students have been provided with such a great exposure. It was a great opportunity for all the students as a milestone for their career development. The internship focused on the research training of the students. Each student had been given a research project of either their own topic of interest or a topic related to the organization's ongoing research. Supervisor's constant advice and guidance proved to be vital for all the research projects. The students were assisted for the equipment and all the necessary books and journals.

- SCERT Internship

Internship program for Add-on- Course (GUIDANCE AND COUNSELING) students was organized in State Council of Sector Educational Research and Training (SCERT), Sector 32 Chandigarh from **21st October 2019 to 31st October 2019**. 15 students of Advanced Diploma of Guidance & Counselling have had an enriching internship experience and Psychology Resource Centre of State Council of Education and Research. Students gained practical experience and knowledge about conducting and interpreting psychological tests for assessment and diagnosis purposes.

19. Best Practices Adopted

1. Wall Magazine: Awareness of the issues, concerns and recent trends in Psychology is generated amongst the students.
2. Study Groups: Study groups are formed with the objective of peer mentoring and bringing about cohesiveness amongst the fellow students.
3. Research Projects: Student groups are formed to initiate research activities in unison, irrespective of classes.
4. Psychological Testing: Interest, Ability, Personality testing and Mental Health Assessment for fellow students and faculty is carried out by the students of the department.
5. Community Outreach
6. Audio-visual presentation: For making teaching-learning more participative, audio-visual presentations are used.
7. Senior students share their experiences with the junior students regarding curricular/co-curricular experiences.

20. Faculty Scholarships

Three of our faculty and ex-faculty members, Mrs. G. K.Dhir(ex-faculty), Dr Neelam Rattan (ex-faculty & alumna) and Dr Kuldip Kaur have instituted scholarships for the students excelling in Psychology exam.
