## MEMORANDUM OF UNDERSTANDING

This MEMORANDUM OF UNDERSTANDING (MoU) is made on *20<sup>th</sup> March, 2025*

By and Between

It is affiliated to Panjab University, which is one of the oldest universities of India (hereinafter referred to as "**First Party**") represented by its principal, having its campus and main office in Sector 11, Chandigarh

And

**B.M.C (Badala Maths Classes)**, YMCA Building, Sector-11, Chandigarh acting through its Director as the second party.

**Post Graduate Government College for Girls, Sector 11, Chandigarh (PGGCG-11)** is a premier institution affiliated with Panjab University and accredited with an 'A' grade by NAAC. Established in 1956, it provides quality education in a green, conducive learning environment. Known for excellence in academics, sports, and extracurricular activities, the college follows the motto "Courage to Know," fostering critical thinking and leadership. Its 35-acre campus offers modern infrastructure, diverse programs, and career-oriented courses. Committed to social responsibility, sustainability, and holistic development, PGGCG-11 has earned national and global recognition. **Badala Maths Classes, Sector 11, Chandigarh** is a premier Institute cum Mentoring Organisation dedicated towards Career building, skilling, Mentoring students towards Career Opportunities in Various Governments Sectors like CDS, AFCAT, SSC-CGL, CPO, RAILWAY, BANKING & OTHER STATE GOVERNMENT EXAMS Conducted by State Selection Commissions of different States. It helps them to acquire Stability and Economic Security at right stage in College Itself. In the short span of its existence, Badala Maths Classes has come to be known as the most trustable Institution due to the Final Selection of Chandigarh students in above said Government Exams. ## OBJECTIVES OF MOU

This MoU is executed for promoting skills for competitive exams like CDS, AFCAT, SSC-CGL, CPO, Railway, Banking & mentoring of student towards multiple career options during and after graduation, students knowledge enhancement programmes in English speaking and basics of English & related activities.

In particular, this MOU is intended to: -

1. **Aptitude and English Skill Development** – Organizing lectures and sessions with successful candidates from various government services (SDM, Assistant Commandant, Lieutenants) to enhance students' aptitude and English proficiency, fostering government job opportunities.
2. **Career Acceleration Program** – A structured mentoring initiative aimed at bridging the gap between academic learning and the practical skills needed to excel in competitive exams.
3. **Regular Test Series** – Conducting frequent assessments to provide hands-on experience, helping students apply their knowledge under real exam conditions, improving their employability, and giving them a competitive advantage.
4. **Flexible Learning Modes** – Offering classes in both offline and online formats, with bilingual instruction (English and Hindi) to support students from rural backgrounds.

This MoU will also serve purpose of Atmanirbhar Bharat, Pradhan Mantri Rojgar Protsahan Yojana (PMRPY) and National Career Service (NCS) Project of Ministry of Labour and Employment and Pradhan Mantri Kaushal Vikas Yojana (PMKVY), Prime Minister's Employment Generation Programme (PMEGP) through inspiring and motivating the young minds, students for career and Competition oriented skills.

**THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:**

**Clause -I: Financial Obligation**

- There will not be any financial obligation on any party. No fees will be collected from students and no remuneration will be offered to any resource person.
- The second party will make sure that no damage to the Government property is caused during their interaction with the students.

**Clause-II: Cooperation**

- Both parties share common interests and objectives and will establish communication and cooperation channels to enhance their collaboration.
- They will keep each other informed about potential opportunities and share relevant information to secure additional prospects.
- The partnership will enable the effective use of the Second Party's intellectual expertise.
- The Second Party will provide valuable inputs, hands-on classes, and sessions to develop suitable teaching and training systems tailored to the needs of the First Party.

**Clause- III: Scope of the MOU**

- The agreement is valid for three years from the date of signing.



- The MOU becomes effective once signed by representatives of both parties.
- It will remain in force for three years, with the possibility of extension upon review and mutual agreement.
- Either party can terminate the MOU with a 30-day written notice.
- Upon termination, both parties are required to fulfill their obligations.

#### Clause- IV: Coordination

Both the parties will appoint one member of their staff to coordinate the programme on its behalf. Further the coordination committee, consisting of

- a) Post Graduate Government College for Girls, Sector-11, Chandigarh
- b) Director, Badala Maths Classes
- c) Program Coordinator of First Party
- d) Program Coordinator of Second Party

We Will periodically review and identify ways to strengthen connection between the two parties.

#### Clause- V: Arbitration Clause

Should there be a dispute relating to any aspect of the MOU, Principal, Post Graduate Government College for Girls, Sector-11, Chandigarh, and the Director, Badala Math's Classes, Chandigarh

Second Party will jointly resolve the dispute in a spirit of independence, mutual respect and shared responsibility.
