Regional Centre for Entrepreneurship Development (RCED) is a Non-Government organization registered under Society Registration Act (XXI if 1860). RCED came into existence during 1995 and is committed to promote Entrepreneurship and Skill Development, in the States of Punjab, Haryana, Himanchal Pradesh, Uttar Pradesh, Maharastra, Uttrakhand, Rajasthan, Delhi and union Territory of Chandigarh, by motivating and training unemployed and under employed youth. Programs are undertaken on behalf of Various Central Ministries, State Govt. Departments, All India Financial Institutions, Banks, MSDC, State Skill Missions, Corporates. Some of them are NASSCOM Foundation, Tech Mahindra Foundation. Power Finance Corporation, SCI, SJVN, Lab Path Lab Foundation, IRCON etc.

Whereas both parties having expertise in their respective fields can benefit the students in the field of Skill and Entrepreneurship Development. Both the parties have agreed to work together in the following fields:-

- That RCED would collaborate with the college in conducting programmes an Entrepreneurship development program sponsored by Department of Science and Technology, Govt. of India, Directorate of Industries, Khadi and Village industries Commission (KVIC), Govt, of India, National Skill Development Corporation, Tech Mahindra Foundation, Zoho Books, SJVN, PFC etc.
- 2. That Entrepreneurial Awareness Camps (3 days duration) would be conducted by (RCED) for the students of the college, giving them awareness about entrepreneurial opportunities and information about facilities available for settings up their even enterprises.

- 3. That Entrepreneurship Development Programmes (4 Weeks Duration) would be conducted by RCED for those who are ready to set up their own units. All inputs from project identification, selection to successfully running the ventures shall be provided during the training.
- 4. Skill Development Programmes would be conducted for the candidates looking for the wage employment in the field of IT, Computerized Accounting, Tally, Retails, Sales, Computer applications, Textile, Food Processing, Fashion Technology etc. Communication Skill, Personality Development and IT skill will be one of the modules in each Entrepreneurship and Skill Development Program.
- 5. RCED will extend handholding support to all the participants of different programmes in getting them placed or start their own ventures.
- 6. That Faculty Development Programme (FDP) of short duration would be conducted by RCED with the objective:
  - a. To help the faculty to understand the needs of students in present economic scenario.
  - b. To develop their capability in designing and implementing a comprehensive small business and entrepreneurship development package for their students.
  - c. To develop the knowledge and counseling skills related to launching and managing small industrial/business ventures.
  - d. To inculcate abilities in the faculty so that they are able to motivate the students to opt self-employment as a career.
  - e. To provide information to the participants about various sources for getting training and research assignments for the college.
- 7. If, during the course of our association, we initiate any new collaboration for skill-related trainings, workshops, or similar programs, we agree to give priority to starting such initiatives at your institute, subject to mutual consent on terms and conditions.
- 8. That College would extend infrastructural facilities for the conduct of seminars/conferences/workshops etc.
- 9. That College will promote programmes related to entrepreneurship and skill development amongst students.
- 10. That College will ensure the participants complete the program without dropout.
- 11. That both the parties may nominate members to various seminars and conferences on entrepreneurship and skill development being organized by respective parties.
- 12. The duration of the MOU will be three years from the date of signing; it can be renewed with the consent of both the parties.

13. There will not be any financial obligation on college and its students.
