#### By and Between

Post Graduate Government College for Girls, Sector 11, Chandigarh, a premier multi-faculty institution of higher education in Chandigarh. It is affiliated to Panjab University, which is one of the oldest universities of India (hereinafter referred to as "First Party") represented by its principal, having its campus and main office in Sector 11, Chandigarh

#### And

ITInker Learning Foundation, a non-profit organisation registered under Section 8 of the Companies Act, 2013, registered at H.NO 0637 SARAVHITKARI SOCIETY SECTOR 48 A CHANDIGARH 160047 and office at THIRD FLOOR PLOT NUMBER 575 C JLPL INDUSTRIAL AREA SECTOR 82 SAHIBZADA AJIT SINGH NAGAR PUNJAB 140308, hereinafter referred to as "ITinker" (which term shall mean and include, wherever the context so requires or admits, its successors and permitted assigns), of the ONE PART represented by its Chief Happiness Officer (hereinafter referred to as "Second Party").

Post Graduate Government College for Girls, Sector 11, Chandigarh (PGGCG-11) is a premier institution affiliated with Panjab University and accredited with an 'A' grade by NAAC. Established in 1956, it provides quality education in a green, conducive learning environment. Known for excellence in academics, sports, and extracurricular activities, the college follows the motto "Courage to Know," fostering critical thinking and leadership. Its 35-acre campus offers modern infrastructure, diverse programs, and career-oriented courses. Committed to social responsibility, sustainability, and holistic development, PGGCG-11 has earned national and global recognition.

#### AND

iTinker is engaged in promoting education, technology, and innovation through hands-on learning, workshops, certification programs, and incubation support. It is dedicated to nurturing young minds with the aim of fostering innovation and bridging societal gaps using technology.

Both Parties have agreed to collaborate on promoting technology, skill enhancement, and innovation through structured initiatives, including the establishment of an incubation centre at PGGCG-11.

#### **PURPOSE**

To collaborate for the promotion of technology, innovation, entrepreneurship, and skill enhancement among PGGCG-11 students through workshops, training programs, skill development courses, incubation support, and other educational initiatives under the COLLABORATIVE BANNER OF both parties

#### **DURATION**

This MoU shall remain valid for a period of Three (3) years from the date of signing and may be extended upon mutual written agreement.

#### SCOPE OF COLLABORATION

iTinker, in collaboration with PGGCG-11, shall:

- Organise workshops and training programs on emerging technologies such as Robotics, IoT, AI, 3D Designing & Printing, Web and Mobile App Development.
- Facilitate certification programs on digital tools and emerging skills.
- Organise competitions, exhibitions, and innovation showcases.
- Provide mentorship for research, innovation, and entrepreneurship development.
- Select aspiring volunteers to assist in conducting impactful workshops across institutions.
- Utilize the Skill Lab of PGGCG-11 for delivering these programs, ensuring access to required facilities and resources.
- Establish an Incubation Centre within PGGCG-11 premises to nurture student innovations and entrepreneurial projects, providing mentorship, networking opportunities, and incubation support.

#### **RESPONSIBILITIES OF ITINKER**

- Design and deliver structured programs, workshops, and certification courses.
- Offer training and orientation on emerging technologies.
- Issue participation and completion certificates as applicable.
- Regularly review and report the progress of collaborative activities.
- Ensure that trainers, mentors, and guest faculty provided are qualified and experienced.
- Maintain records of participants and share periodic reports with PGGCG-11.

#### **RESPONSIBILITIES OF PGGCG-11**

- Provide logistical support, including classrooms, labs (including the Skill Lab), and necessary facilities for workshops and training sessions.
- Facilitate student and faculty participation in collaborative programs.
- Support the promotion of initiatives conducted by iTinker within the institution and community.
- Provide space and basic infrastructure for setting up the Incubation Centre.
- Assist in coordinating administrative tasks related to program execution and certifications.

#### INTELLECTUAL PROPERTY RIGHTS

- All intellectual property developed solely by iTinker shall belong to iTinker.
- Jointly developed intellectual property shall be subject to separate agreements outlining shared ownership rights.
- PGGCG-11 shall not use iTinker's proprietary content without prior written consent.

#### CONFIDENTIALITY

- \* Both Parties shall maintain the confidentiality of information shared under this MoU, unless required by law.
- The confidentiality clause shall remain effective even after the termination of this MoU for a period of two (2) years.

#### **EXPENDITURES**

- All financial responsibilities and expenditures related to activities under this MoU shall be decided upon mutual consent and documented in written agreements before initiating any activity.
- There will not be any financial obligation on college and its students.

#### **TERMINATION**

- Either Party may terminate this MoU by giving thirty (30) days' prior written notice to the other Party.
- Upon termination, all ongoing activities shall be wound up, and outstanding obligations shall be settled amicably.

#### **AMENDMENTS**

Any amendments to this MoU shall be made through a written agreement signed by authorized representatives of both Parties.

#### **NOTICES**

All official communication and notices under this MoU shall be sent to the addresses stated herein or to such other addresses as may be designated in writing by either Party.
